#### CORPORATE AGREEMENT APPLICATION

This agreement, together with any operating rules, policies, price schedules, or other supplemental documents expressly incorporated herein by reference and published from time to time by Lakeview Limousine Inc (collectively the “Agreement”), constitutes the entire agreement between Lakeview Limousine Inc and you regarding the services of Lakeview Limousine Inc, and supersedes all prior agreements between the parties regarding the subject matter of this Agreement. For purposes of this Agreement, “services” are defined as any and all car and limousine services provided by Lakeview Limousine Inc to you, your agent(s), employee(s) or assign(s) either now or in the future. By using the services of Lakeview Limousine Inc, you confirm your acceptance of, and agree to be bound by this Agreement.

#### Charges

- a. You agree to pay all charges for your use of the services of Lakeview Limousine Inc at the prices then in effect. Lakeview Limousine Inc reserves the right to change prices or institute new charges for its services. You are responsible for regularly reviewing, obtaining and confirming such pricing information. Continued use of the services of Lakeview Limousine Inc or non-termination of your account after changes are posted constitutes your acceptance of the prices as charged.
- b. Prices do not include parking, extra stops, or waiting time, and all charges will be exclusive of a Chauffeur’s gratuity of 20% (twenty percent), which will be automatically added to your bill.
- c. Each time you use the services of Lakeview Limousine Inc, or allow or cause the services of Lakeview Limousine Inc to be used, you agree and reaffirm that Lakeview Limousine Inc is authorized to charge your designated credit card.
- d. You agree that Lakeview Limousine Inc may (at its option) accumulate charges incurred during your billing cycle and submit them as one or more aggregate charges during or at the end of each cycle, and that Lakeview Limousine Inc may delay obtaining authorization from your card issuer until submission of the accumulated charge(s). This means that accumulated charges may appear on the statement you receive from your card issuer.

#### Customer Representations

You represent and warrant that you are at least 18 years of age or, as applicable, the age of majority in the state or province in which you reside, and that you possess the legal right and ability to enter into this Agreement. You agree to be financially responsible for the use of the services of Lakeview Limousine Inc (as well as for use of your account by others, including those persons employed by you and to comply with your responsibilities and obligations as stated in this Agreement.
